5WAIVER OF REMEDY AND STATEMENT OF AGREE RULES OF BMW 02 CLUB THE NETHERLANDS AND BMW TOURING CLUB THE NETHERLANDS

- 1. The organization is in the hands of BMW 02 Club the Netherlands and BMW Touring Club the Netherlands. Every participant and spectator undertakes to strictly comply with all rules and instructionss of the organization.

The organization also has the right to remove people from the track in all cases it deems necessary, without refund of the participation fee.
- 4. Each participant, driver, co-driver and spectator will have to fill in a waiver of remedy and agreement of these rules, which is done by signing this form, whereby the conditions of the Midland Circuit Lelystad are also accepted.
- 5. Participation in this day is entirely at your own risk. The organization is not liable for any form of damage. This applies, among other things, to damage to the cars, damage to the circuit, but explicitly also to personal injury and any consequential damage resulting from injuries sustained. - 6. The organization, the instructors, volunteers or the marshalls can under no circumstances be held responsible for damaged, lost or stolen goods.
- 7. It is expressly not allowed that a car is lent to a non-registered person to participate in this event.
- 8. Wearing a helmet is mandatory at all times, both for drivers and for any co-drivers.
- 9. No rider shall endanger himself or other riders. Sportsmanship is paramount and any form of competition is excluded. A rider violating this rule may be disqualified from further participation in this event without any compensation.
- 10. Under no circumstances is it allowed to stop on the track or to drive against the direction of travel, not even in the event of an accident. In the event of an accident on track, you should complete your lap calmly and enter the pit lane at the first opportunity.
- 11. Spectators are prohibited along the course except at the specifically designated spectator areas.
- 12. The participant expressly undertakes not to drive under the influence of alcohol, other narcotics or medicines that may affect driving ability.
- 13. In case of temporary or permanent cancellation of this event for whatever reason, the organization, instructors, volunteers or marshalls cannot be held liable. In that case, the participants cannot claim a refund, nor claim any other costs incurred.
- 14. The organization reserves the right to place photos, films and live video images of this event on the website of the organization or to use them for other promotional purposes.
- 15. Exclusion from participation may follow if these rules are not observed.
